### Summary

On 08/10/08 at about 0850 hours, Officers Barr, Holmes and I responded to 2511 Avenue J in reference to a rescue run. Upon arrival the residence had been entered forcibly through the back door. Shell casings from \_\_\_\_\_ caliber rounds were on the ground. Bullet holes were in the walls and the bedroom door. The Victim was found deceased inside the room. A crime scene was established, detectives and supervisors were notified. The investigation was turned over to Det. Braun.

### Narrative

On 08/10/08 at approximately 0843 hours, Officers Holmes, Barr and I responded to 2511 Avenue J, in reference to a rescue run. A caller advised that [redacted] went to check on the victim, later identified as [redacted]. The caller advised the backdoor of the residence had been kicked in and [redacted] was laying on the floor not moving. The caller advised there was "holes" in the walls and doors. 911 advised the caller to exit the premises.

Upon arrival, we found the front door of the residence locked. We walked on the west side of the house to the rear. The back door of the residence had been kicked open. A smeared shoe print was on the white door. We announced "police" and entered to secure the residence. Several machetes and knives were in close proximity to the back door laying out. We walked into the living room and I saw shell casings on the chair and on the floor.

The [redacted] bedroom door was shut. [redacted]. The door was locked. Officer Holmes kicked the door open. [redacted] was lying on the floor, blocking the door from opening more than halfway. [redacted] was in a fetal position on his left side, head to north feet to the south.

We advised the scene was secure. Lt. William French, Rescue 15 ID # 304, pronounced [redacted] deceased at 0854 hours. The scene was established and Sgt. Hurtado and Lt. Smith responded. Officer Barr kept the crime scene log. Det. Braun and Sgt. Christman responded and the investigation was turned over to Det. Braun. No next of kin for the deceased was advised at this time. The Medical Examiner was not notified at the time of this report.

A neighborhood canvas revealed that at about 2330 hours on 08/09/08, neighbors heard gunshots. I collected two witness statements on scene and turned them over to Det. Braun.

Nothing further from this officer at this time.
