Narrative

On 06/21/07 DCF worker Janice, victim [redacted], her sisters [redacted] and [redacted] came to the police department to the detective Bureau and spoke with detective Larkins regarding a sexual abuse allegation.

The victim Ms. [redacted] who is now 18 years old and who was twelve or thirteen years of age at the time of the crime, stated that her grandmother's boyfriend Archie Hill has been touching her. [redacted] stated that her grandmother [redacted] has custody of her and [redacted] 14 year sister) because their mother was incarcerated. [redacted] stated that her grandmother moved out and left them at Archie's house. [redacted] stated that Archie has been touching her breast and butt for a while. [redacted] stated that Archie would block the door so she couldn't pass. She also stated that he told her that he would give her twenty dollars to touch her. [redacted] stated that Archie is a Bus driver. [redacted] stated that she believes her grandmother [redacted] has a deal with Archie for them to stay with him for tax purposes.

Ms. [redacted] who is also a victim (victim # 2) stated that Archie did her the same way and more and she reported him to DCF. [redacted] stated Archie had sex with her when she lived with him. [redacted] stated that she did not want to report what Archie did to her but want to protect her little sister. [redacted] stated that her sisters can live with her because she was living on an Indian reservation. Janice from DCF stated that it was okay and advised [redacted] that she will have to do a background check on her before they can be place with her permanently. [redacted] stated that she called her grandmother and told her what [redacted] said about Archie. [redacted] stated that her grandmother did not believe her and calle [redacted] a liar.

On 10/15/08, I received this case for continue follow up investigation. I spoke with one of the victim on the phone and met with her on 10/17/08. I made arrangement to meet with both of them on 10/20/08 along with a victim's advocate from the State Attorney's Office.

On 10/20/08, at 09:30 A.M., the victims arrived at the police department for an interview. Both victims were interviewed separately. Before the interview, I presented a photo array of six photographs to the first victim Ms. [redacted] stating that the suspect may or may not be in the line up. After showing her five of the pictures, she was able to recognize the suspect, her grandfather from the line up. The victim then went on to explain what had happened.

The victim Ms. [redacted] stated that in 2003 when she was about 12 years old, she and victim # 2 and another sibling were living with their grandmother at [redacted]. She stated that one day, her grandfather the suspect asked her grandmother if she would let her go with him to wash and clean the school bus. Her grandmother agreed and allows her to go. The victim said that the suspect, who was living by himself at a different location 2202 Avenue I, took her to his home and performed lewd and lascivious acts on her. The victim said that she later moved in with her grandfather because he was living closer to the bus stop where she had to catch the bus in the morning to go to school.

She said that the suspect asked her for a hug. The victim said that she hugged him and did not think anything of it because she trusted him as her grandfather, and that he usually asked for hugs whenever he came to visit. The victim mentioned that this hug was kind of unusual. She said that the suspect held her real tight and started to rub on her breasts and her buttocks. The victim stated that she tried to get away from him several times but she was too strong and over powering. She said that he kept asking her if he could be with her but she said no. She said that when he finally let go of her, she went to her room.

The victim said that a short while after, the suspect came to her room and sat on her bed. The victim said that she was lying down at the time when the suspect tried to hold her hand, but she wouldn't let him. He then asks her if she knows about sex and especially oral sex. He asks if she is still a virgin or has she slept with anyone yet. He tells her he will give her \$20 if she would let him touch her. I asked her if he touches her over or under her clothing. She stated that is was over her clothes. This has been happening one to two times per month and she does not want this to keep happening, so she told a relative. The relative is the one who filed a complaint with DCF and who is also victim # 2 of the same suspect. The victim said that the suspect stop abusing her for a while when her younger sister came to stay at the grandfather's house.

Victim # 2 Ms. [REDACTED] was then interviewed. She was also showed a set of photo array and she too positively identified the suspect. Ms. [REDACTED] is also the grand daughter of the suspect. She said that she went to visit with her sisters in May of 2007 and took them, [REDACTED] victim # 1 and her younger sister ([REDACTED] 14 yoa) to stay with her for a while on the Indian Reservation. She said that while they were there, she noticed that the victim was not her usual self; she was withdrawn so she pressed her to tell her what was going on. Ms. [REDACTED] suspected that the suspect might have been abusing her as he did to her when she was eleven years old herself. Ms. [REDACTED] said that her fear had came through when the victim broke down crying and started to tell what the suspect have been doing to her.

Ms. [REDACTED] victim # 2 who is now 21 years of age, then started to tell me what had happened to her when she was 11 years old. The victim stated that the suspect started to sexually abused her since 1997 when she was about eleven years old, and stopped in 2003. She said that the first time that he sexually abused her was when she was living at [REDACTED] off Airport Road. She said that the suspect, who was known as coach Hills in the neighborhood, was her base ball and soft ball coach. She said that he usually took her back and forth to her games.

She said that one day, the suspect came by and asked her if she wanted to learn to drive. She was very excited and said yes, so he gave her the keys and got into the vehicle with her and they went driving. The victim (#2) said that as they were driving down Airport road, the suspect turned to her and asked her if she could keep a secret she said yes she could keep a secret she said that her little mind was not thinking of what the suspect was getting at. She said that he asked her again if she could really keep a secret, she said yes she could. The victim said that the suspect then leaned over while she was driving and started to rub her breasts.

She said that she pushed him away and told him to stop and that she was driving. He then said, "I thought you said that you could keep a secret" she said that the suspect then continued to rub on her thighs. The victim said that the suspect then put his left hand down the waist of her clothing into her panties and inserted his finger inside of her. She said that she told him that she wanted to go home. On the way back home, the suspect told the victim that she should not tell anyone, if she does she was going to get into trouble and that no one would believe her.

The victim said that, that was what she did and the suspect then progressed in his sexual abuse of her. She said that on several occasions he had oral sex with her and also inserted his penis into her several times and caused her to bleed. The victim said that the suspect had sexual intercourse with her about fifty times or more. The victim said that one day she mentioned it to her aunt but she got angry and would not believe her. The victim stated that when she got older she left the residence and was able to tell her mother who was very angry and believed her because she too was molested by the suspect when she was younger. The victim stated that she was concern for other kids because the suspect is a school bus driver.

On 10/29/08, the victim Ms. ██████████ made a control phone call to the suspect. The victim asked the suspect about the times when he took her to teach her to drive and while doing so, he asked her if she could keep a secret, she stated yes, the suspect then inserted his finger inside of her vagina from there, he spent about five years having sexual intercourse with her. During the phone conversation, the suspect did not deny having sex with her. He said, "I know what you are talking about, I don't know what to say whatever is in my past is in the past that is why I just don't know what to tell you, I just don't think about the past, I always look to the future I don't look back, so I just don't know what to tell you". The victim also asked the suspect if he was sorry for what he did to her, he stated that he was sorry for everything that he had done to anyone and that he had never tried to go back into the past. He did denied that he did have sexual intercourse with the victim's sister but admitted that he did hugged her as the victim as mentioned.

The victim stated that she wants to press charges.

These Are Therefore to Command you to forthwith arrest and bring the above named defendant before me to be dealt with according to law.

Bail Bond is Fixed at \$ No Bond.

Condition of Bond Release/Release on Recognizance:

No Contact With Victim: Until further order of the Court or the charge is dismissed by the State, the Defendant shall not directly or indirectly contact the Victim _____ in person, by mail, e-mail, fax, telephone, through another person, or in any other manner. This restriction shall include the following condition(s), if marked:

- Defendant may not knowingly come closer than 50 feet to the Victim at any public place, except for court proceedings, or within 500 feet of the Victim's residence or place of employment, or 100 feet of any vehicle regularly driven by the Victim;
- Defendant may go to Victim's residence one time with a law enforcement officer to get Defendant's clothing and personal effects;
- Defendant may speak to Victim on the telephone *only* to discuss sharing parental responsibility for their minor child(ren).
- If marked, Defendant shall be held without bond until the First Appearance Hearing.
