### Narrative

On 11/06/08, at approximately 2035 hrs, Ofc McGlon, Ofc Maldonado, Det Grecco, Det Thayer, and I responded to the area of Raymond Avenue in reference to shooting activity.

The information was called in by and anonymous party refusing to provide his name. The call was traced to the area of 2911 Okeechobee Rd.

NOTE: 2911 Okeechobee Rd is approximately a 1/2 mile West of Raymond Avenue.

While in the area of Raymond Avenue (1100 Block) searching for a possible crime scene, Ofc Pate (Lawnwood Detail Officer) received a flag down in reference to a home owner that shot and killed a burglar in his residence located at 1223 Raymond Avenue.

This information was transmitted, via radio, at approximately 2054 hrs by Ofc Pate. Ofc McGlon, Ofc Maldonado, Det Grecco, Det Thayer, and I responded to 1223 Raymond Avenue and surrounded the residence. We were quickly informed by neighbors at 1221 Raymond Avenue that the residence at 1223 Raymond Avenue was vacant.

I contacted Ofc Pate, via radio, who advised that the complainant stated that he made a mistake and the correct address 1222 Raymond Avenue.

Sgt Hall responded to the scene.

We then traveled across the street to 1222 Raymond Avenue. Upon arrival a tall W/M exited the residence with his hands above his head. He was ordered to a sitting position approximately 50 feet the front door of his residence.

The W/M victim informed Ofc Maldonado that three armed B/Ms (suspects) wearing all black clothing, including gloves and masks, entered his residence and attempted to rob him. Det Thayer, Sgt Hall, and I cleared the residence. We observed a B/M (suspect) lying on his back in the doorway to the residence. The suspect was motionless and appeared to have a very weak pulse. The suspect was approximately 30 years old, wearing a black long sleeve shirt, black shorts, black gloves, and a black ski-mask.

Rescue immediately began treatment on the suspect until he was transported to Lawnwood Regional Medical Center where he was pronounced deceased at 2145 hrs by Dr Soto. The deceased suspect was identified as Isaac Collins.

Sgt Gillette, Sgt McWilliams, Det Perkins, Det Cuti, and Deputy Chief Nygaard responded to the scene.

The victim was identified as Glenn Hedrick; He was transported to Lawnwood Regional Medical Center for a possible gunshot wound.
