FORT PIERCE – At about 6:27 p.m. Saturday, officers responded to 805 Dayman Avenue in reference to a stabbing.

Upon arrival, officers found a Hispanic male, with cuts to his abdomen, lying inside the residence. St. Lucie County Fire Rescue transported the victim to Lawnwood Regional Medical Center and Heart Institute. He was later pronounced dead at 2:50 a.m.

The suspect, Jose Luis Aparicio, fled the area on foot, leaving the weapon at the scene. Aparicio was found at 807 Revels Lane and arrested. He was transported to the St. Lucie County Jail where he faces two felony charges: murder and aggravated battery with a deadly weapon.

This is the second homicide of 2010 for the City of Fort Pierce.

Narrative

On 04/03/10 at 6:31 pm, I responded to 805 Dayman Ave, in reference to a stabbing.

Upon my arrival I met with four (4) witnesses (Rafael Perez Ayunga, Baltazar Mendoza Aguilar, Rogelio Zamudio Chaves and Francisco Dominguez Luna), who stated that the suspect's name was Luis Aparicio and that they witnessed him exiting the residence with a knife in his hand and when he approached them he stabbed the ground two or three times. The witnesses all stated that after Aparicio stabbed the ground he threw the knife on the ground and took off running southeast on Dayman Ave.

All four witnesses described Aparicio as a Hispanic male approximately 25-30 years old, approximately 5'3" - 5'5" tall, thin built last seen wearing blue pants, a black hooded sweatshirt, black Nike sneakers, thin mustache and beard.

Officers set a perimeter while K-9 Officers attempted to track the suspect without any avail.

Officer Yaffey maintained the crime scene and crime scene log.

Detective Grecco arrived on scene and took over the investigation.

While looking in the living room for any evidence I saw what appeared to be a pay stub in plain view with the name Luis hand written on it. When I opened the pay stub the name Nicolas Ventura and the address 1021 Sunrise Blvd where on it. I asked Officer Trinidad to go to that address to see if Aparicio was there but he stated that the residents told him that he was not there, approximately 20 minutes later Fort Pierce Dispatch advised that a male by the name of Antinio Guerra called and stated that Aparicio had gone to his residence and asked him for a ride to an address on Revels Lane (see officer Trinidad's supplemental report).

I helped Detective Grecco translate with the interview of all four witnesses (see Detective Grecco's report).
